1. AGREEMENT TO TERMS

Please read these **Event Terms and Conditions** ("Terms and Conditions") carefully before booking. By purchasing a ticket or attending the retreat, you acknowledge that you have read, understood, and agreed to be bound by these Terms and Conditions.

In these Terms and Conditions:

- **“You”** or **“Attendee”** refers to the participant attending the retreat.
- **“We”, “Us”,** or **“Retreat Organizers”** refers to the hosts of *Come Back to You: Bali Retreat* including Mel Ryan and associated facilitators.

These Terms and Conditions govern your participation in the *Come Back to You: Bali Retreat*, including event details, payment, cancellation policies, liability, and other important information.

2. RETREAT OVERVIEW & ITINERARY

2.1. Retreat Description

- The retreat details, inclusions, and itinerary are listed on the official **Retreat Booking Page**.
- The itinerary is subject to change due to unforeseen circumstances, weather conditions, or facilitator availability. Any significant changes will be communicated to attendees.

2.2. Inclusions

Your retreat package includes:

- ✓ 5-night luxury accommodation at Amori Retreats
- ✓ Daily breakfast, dinner, and most lunches
- ✓ All guided sessions, activities, and retreat materials

- ✓ Massage
- ✓ Access to the infinity pool, yoga shala, and relaxation areas
- ✓ Support from our dedicated retreat team

2.3. Exclusions

Your retreat package does NOT include:

- ✗ Airfare and travel costs to and from Bali
- ✗ Personal expenses (shopping, additional food or drinks outside the provided meals, souvenirs, etc.)
- ✗ Travel insurance (highly recommended)

3. TICKETS & ENTRY REQUIREMENTS

3.1. Tickets & Booking Confirmation

- You will receive a confirmation email after booking, which serves as your ticket to the retreat.
- Your ticket is non-transferable and non-refundable, except under the conditions outlined in **Section 5 & 6**.

3.2. Identification & Check-in

- A valid form of identification (passport or government-issued ID) must be presented at check-in.
- Attendees must complete any pre-arrival forms (medical questionnaire, waiver, or consent forms) before attending.

3.3. Retreat Etiquette

- We reserve the right to refuse entry or ask a participant to leave if they are under the influence of drugs/alcohol, disruptive, or creating an unsafe environment for others.
- No refunds will be provided for attendees removed for violating retreat policies.

4. PAYMENT TERMS & FEES

4.1. Retreat Pricing (AUD)

♥ **Single Room:** \$3,450 AUD

♥ **Shared Room:** \$3,200 AUD

4.2. Deposit & Payment Plan

- A **\$1,000 deposit** is required to secure your spot.
- The remaining balance is due **3 weeks before the retreat start date** (by June 2, 2025).
- Payment plans are available upon request.

4.3. Additional Fees

- Any **bank transfer fees, currency exchange fees, or payment processing fees** must be covered by the attendee.

5. REFUND & CANCELLATION POLICY

5.1. All Sales Are Final

- Due to the intimate nature of this retreat, **ticket sales are final, non-refundable, and non-transferable** except as stated below.

5.2. Cancellations by the Attendee

- If you need to cancel, you may receive a **credit toward a future retreat** if canceled **at least 60 days before the retreat start date** (before April 23, 2025).
- No refunds or credits will be given for cancellations made **less than 60 days before the retreat**.

5.3. Cancellations by the Organizers

- If we cancel the retreat due to unforeseen circumstances (excluding force majeure events), you will receive a **full refund (less admin costs) or credit for a future retreat**.
- We are not responsible for refunding **flights, travel expenses, or any costs outside the retreat package**.

6. RETREAT POSTPONEMENT OR CANCELLATION

6.1. Force Majeure Events

- In the event of **natural disasters, travel restrictions, pandemics, political instability, or other force majeure events**, we reserve the right to **reschedule or cancel** the retreat.
- If rescheduled, your booking will be automatically transferred to the new dates. If you cannot attend, you may receive a credit for a future retreat.

6.2. Refunds for Postponed or Cancelled Retreats

- If a retreat is **canceled without rescheduling**, attendees will receive a refund of the retreat price minus any non-refundable expenses already incurred.

7. HEALTH & SAFETY AGREEMENT

7.1. Medical Considerations

- Attendees must disclose any **relevant health conditions, allergies, or injuries** that may impact their participation.
- The retreat organizers are not liable for **pre-existing health conditions or injuries sustained during the retreat**.
- If you have **serious health conditions (heart issues, epilepsy, pregnancy, or recent surgeries)**, consult a doctor before booking.

7.2. Travel Insurance

- We strongly recommend **purchasing travel insurance** that covers trip cancellations, medical emergencies, and travel disruptions.

7.3. Emergency Medical Assistance

- In the case of a medical emergency, attendees authorize retreat organizers to **seek necessary medical care**. Any associated costs will be the responsibility of the attendee.

- Any personal discussions or coaching shared in group sessions will be treated with **strict confidentiality**.
